6. SFS Project

Meetings have taken place in relation to the Aberdeenshire Asset Fund for Communities and the Trust will be meeting to discuss possible Fairer Scotland Funding, and Leader funding.

A list of grant-awarding Trust funds is being drafted and the Trust are working through them in a rolling programme. The Trust has also contacted other parties to begin further consultation work in the village.

7. Community Garden

The Steering group has joined the City Farms and Community Gardens, which will provide valuable information to the group. They are working towards submitting an application for Planning permission for change of use of the site. This will cost and would be met from the community health budget.

8. Town Centre

Together with Fraserburgh Forward Business Association, the Trust is reworking an application for funding for 'Super Saturday' which includes a Community Market and

business development elements, however, due to the forthcoming Christmas Late Night Shopping event it is envisaged that this project will be delayed slightly.

9. Regeneration

The Trust has two members on the Regeneration team and working with Fraserburgh Forward has put forward a strategy paper to council officials for consideration in the brief being prepared for the feasibility study.

10. Fraserburgh Sports Hub

A report was given on working with local sports groups through the Sports Hub Committee. A total of 21 coaches and sports coordinators have recently gained their first aid certificates.
